Technological Innovation tax credit (45% of the expenses related to design, development of 1st prototype, implementation and validation may be deducted)




Deduction for investment in fixed assets: **25%**



RIC: up to 90% of tax liability could be deducted, if reinvested in new fixed assets or employment creation




- CDTI (up to 33% non-reimbursable funds)

 - National: Enisa (up to €1.5M)

 - Island: SPEGC (up to €200k) Gran Canaria is the only island with a financial instrument for digital creative projects
